



DISTRICT OF COLUMBIA BOARD OF ELECTIONS SIGNATURE REQUIREMENTS FOR THE JUNE 4, 2024 PRIMARY ELECTION

Pursuant to D.C. Official Code § 1- 1001.08 (i)(3)-(4), the signature requirements for candidates to appear on the ballot in the June 4, 2024 Democratic, Republican, and D.C. Statehood Green Primaries are listed below, by party and office. Signatures gathered must be those of voters who are registered in the candidate’s party on the date of signing the petition. For the ward offices, petition signers must also be duly registered to vote in the same ward from which the candidate seeks nomination. For the D.C. Council offices, petition signers can also include duly registered voters who are local residents/non-US citizens. [D.C.
