## BACK UP PLAN : INNOCENCE Project

quote: If American republic is going to survive in anything like the form instituted in the constitution by its framers, as amended at regular intervals but especially in a wake of the civil war, The Governments and citizens can play a central role together by addressing urgent issues, concerns, and questions that lie before it in the current time and term. Together - to ignore or rewrite basic constitutional structures and guarantees?

Beginning with protecting citizens human rights under this ballot initiative "INNOCENCE Project" can be your attempt to save innocence stops, ARREST, and convictions. if the opportunity comes that you can be a light to someone else, here's your chance to take it or be it. The nations founders never authorized, and no amendment has ever permitted, a vast administrative state wielding enormous power over citizens.

IF the canidates nomination declares the innocence project to be not merely a bridge too far in the existence of the constitution in its amendments, that would likely mark the point at which the overstretched rubber band of unconstitutional and unaccountable Governments power snaps back.

with such a ruling on this ballot initiative 2024, the candidates nomination would have an opportunity to affirm first principles, binding congress to the construction of new bureaucracies in decades ahead. A direct, forceful restate of the idea that legislators must not delegate to the executive branch their core responsibility would be most welcome. As would the judicial strangulation of Police, Government, deference, an idea repugnant to that of a free people capable of voting out representatives responsible for the failure of any agency to do its job and professionally.

Back up Plan "innocence project" is "politics without romance". The wishful thinking it displaced presumes that participants in the political sphere aspire to promote the common good. In the conventional "public interest" view, public officials are portrayed as benevolent "public servants" who faithfully carry out the "will of the people".

In tending to the public's safety, security, human rights, business, voters, politicians, and policy supposed somehow to rise above their own parochial concerns.

In modeling the behavior of individuals as driven by the goal of utility maximization - economics jargon for a personal sense of well-being

economists do not deny that people care about their families, friends, and community. But public choice, like the economic model of rational behavior on which it rests, assumes that people are guided chiefly by their own self-interest (it has no place in a free society) and more important, that the motivations of people in the political process are no different from those of people in the steak, housing, or car market. They are the same human beings, after all.

As such, voters "vote their pocketbooks," supporting candidates and ballot propositions they think will make them personally better off; bureaucrats strive to advance their own careers; and politicians seek election or reelection to office. Back up Plan, "INNOCENCE project" simply transfers the rational actor model of economic theory to the realm of politics and citizens well-being.

first,  
Back up Plan' innocence project ballot initiative today proposes that citizens be define as a individual in their decision making process and not under collective choice processes link to economics.

Because Two insights follow immediately from economics' study of collective choice processes. First the individual becomes the fundamental unit of analysis.

Back up Plan "innocence project" rejects the construction of organic decision-making units, such as "the people," "the community," or "society." Groups do not make choices; only individuals do. The problem then becomes how to model the ways in which the diverse and often conflicting preferences of self-interested individuals get expressed and collated when decisions are made collectively. This is the cycle that need broken or fix! Because, Secondly, public and private choices processes differ, not because the motivations of actors are different which is one of the reasons) but because of stark differences in the incentives and constraints that channel the pursuit of self-interest in the two settings. This can be very subliminal and unfair to an innocence bystander minority or underprivileged stopped, arrested and convicted illegally or wrongfully, compared to others.

A prospective home buyer, for example, chooses among the available alternatives in light of his personal circumstances and fully captures the benefits and bears the costs of his own choice. The purchase decision is voluntary, and a bargain will be struck only if both buyer and seller are made better off. If, on the other hand, a politician proposes a project or mayor, that promise to protect the new homeowner's community from flooding, action depends on at least some of his neighbors voting

for a tax on themselves and others. Because the project's benefits and cost will be shared, there is no guarantee that everyone's welfare will be improved. Support for the project will likely be forthcoming from the owners of houses located on the floodplain, who expect to benefit the most. Their support will be strengthened if taxes are assessed uniformly on the community as a whole. Homeowners far from the flood plain, for whom the cost of the project exceed expected benefits, rationally will vote against the proposal; if they find themselves in the minority, they will be coerced into paying for it, (indirectly or directly) unless the voting rule requires unanimous consent, which allows any individual to veto a proposal that would harm him, or unless those harmed can relocate easily to another political jurisdiction, collective decision-making processes allow the majority to impose its preferences on the minority.

### Back up Plan "innocence project" Remedy

one key conclusion of Back up Plan INNOCENCE project Remedy is that changing the identities of the people who hold office will not produce major changes in policy outcomes. Electing better people will not, by itself, lead to much better government. Adopting the assumption that all individuals, be they voters, politicians, or bureaucrats, are democratic motivated more

by self-interest than by public interest evokes a Madisonian perspective on the problems of democratic governance. like that founding father of the American constitutional republic, public choice has a Back up Plan that recognizes that men are not angels and focuses on the importance of the institutional rules under which people pursue their own objectives. in framing a government which is to be administered by men over men, the great difficulty lies in this; you must first enable the government to control the governed; and in the next place oblige it to control itself

Institutional problems demand institutional solutions such Human Environment Back up Plan Swap out for M.O.N.E.M.E.N.T & M.I.N.D.S for the Bad for The Good Amendment ACT. 2024.

If, for example, democratic governments institutionally are incapable of balancing the public budget, a constitutional rule that limits increases in spending and taxes to no more than the private sector's rate of growth will be more effective in curbing profligacy than throwing the rascals out." Given the problems endemic to majority-rule voting, Back up Plan INNerence project also suggests that care must be exercised in establishing the domains of private and collective choice; that is not

necessarily desirable to use the same voting rule for all collective decisions; and that the public interest can be best protected if exit options are preserved by making collective choices at the lowest feasible level of political authority.

## 2. Society, prison and adjustment INITIATIVE and NON-rehabilitative and Rehabilitative exchanges

In this chapter we introduce the citizen perspective and a structural analysis of prisoner re-entry to the community.

One way or several ways to address crime rates is to offer citizens in the system rehabilitative exchanges of services from all levels low, medium, and high. From short term, middle, or long term services that will address the individual needs.

One particular service should stop the spread of any disease or behavior; while psychology persist that when you take a way a person defense replace something in the empty position sure we don't want to incarcerate people; However, people must try to help and better themselves independently, this call for accountability and being responsible for self.

And exchanging rehabilitative services is one way we can teach individuals to learn preventive measures, only when preparatory results fail other alternatives must occur. Youths is missing parenting and discipline while force to be a man at a younger age; today acting out the child ages that they never had as a child.

I've been persuaded that thru logical thinking and experience; an negative + negative = positive for example:

a person put their hand in fire is (negative)  
a person screams out loud once the fire burns,  
(negative) Did this occur correctly? Positive  
By the person keeping his hand in the fire  
it suppose to burn and he suppose to scream  
if its too hot right? which make all of the scene.  
Can this be one of the reasons citizens fail to  
comply or lack of resources? Can some people  
be rehabilitative? If we start from the bottom  
to the top; our decision making will result in  
the best interest of citizen and public trust.

If citizen fail to make adjustments to stage one; "zooming"  
stage two will help address total prison populations  
Globally, For example, in 1988 the total population prison  
population in Iowa was 2,890. By 1989 this population  
had grown to 3,322 an increase of nearly 15  
percent. In 1989 there were 2,913 total admission  
and 2,481 total releases. At this rate the state  
will have to build a new medium-size prison every  
year to keep up with the anticipated increase in in-  
carceration. Of these 2,913 new prison admission,  
only 1,156 were new court commitments, while 570  
were revoked probation, 650 were parole violators,  
56 were shock probation returns, 205 were escape

return), 139 were work-release returns, 38 were OWI returns and 99 were other admissions. For 1989, over half of all prison admissions were former prisoners returned on either new criminal charges or revocation of community custody. These revocations of probation, work release and parole were largely due to increases in programme violations rather than new convictions for felonies or aggravated misdemeanours. In effect, the state prison population continue to climb as the result of prison-release failure, as reflected in the rate of community custody revocation.


IF we swap out the return prisoners for rehabilitation one for one; it would reduce the need to waste more of tax payers dollars, land-space and it would always be space to remove violent criminals off the streets. Our goal should be to give the return prisoners better rehabilitative accessibility; Because direct and indirect or collateral consequences of incarceration are reflected in the rules and resources structure prisoners encounter upon leaving prison. The Iowa prison population, like those across the country in numerous states, continues to grow because of its failure to rehabilitate, educate, train, and prepare prisoners for successful re-entry to the community.

The objective of this Back up Plan is to make the

streets safer while offering alternatives before returning. Prisons need exit programmes that properly prepare men and women for release. This programme should include expanded visitation privileges, home furloughs, and family and employment counseling. The pre-release programme or SWAP out should arrange for prisoners to have driver's licences and social security cards before leaving prison.

A SWAP OUT pre release programme needs to be one step in a carefully planned programme of stage release that includes prison vocational and educational programmes, the pre-release programme, and work-release facilities that can allow the men (or women) to attend colleges or universities. If corrections is to mean anything, the person who enters prison is somebody new, and improved upon his or her release.

of equal importance, and perhaps even greater urgency given the nations crime crisis about guns, the idea of "administrative expertise" has never been in more disrepute than now, after the serial fiascos of Court decisions and killing sprees, during which rules imposed by experts devastated the U.S population and safety. The courts are supposed to show deference to government officials who have, in all but name, permanent sinecures? Kill this perverse doctrine, it will not live among us - (The Tried and-True-ideas)

① comprehensive background checks to immediate reduction in firearm death in Oregon,

② permitting-to-purchase law which request people to obtain a license before buying a gun, were associated with reduction in suicides by firearms.

③ another shows a firearm after purchase soon after, both self inflicted gun injuries and injuries inflicted on others rose immediately

This does not protect women who faces domestic violence or any citizen unaware of non-licensed firearm carriers. This ballot initiative proposed that citizens have the right to be aware of non-licensed firearm carriers and license carriers like the same notices are given out for sex offenders near you.

also proposed that firearms be known it's locked by safety while in public places and environments around citizens; why? what if an unlock gun goes off accidentally and hit the nearest bystander? An safety lock tag placed on an firearm that is GPS traceable to prove its lock will do the job.

while the project in D.C involves a community level youth Firearms prevention initiative back by National Institute of Health (NIH) Guns doesn't kill people; it's the bullets that does the killing and this ballot initiative proposed the all Gun owners and sellers exchange their bullets for GPS traceable bullets or ink explodable bullets traceable? An different type of safety lock for guns.

This would determine who is following the rules of safety; Just like phone tracking done all the time, while radar can scan for guns it's not being done as people are dying.

We're clearly asking for rules to be change on Gun locks and Alert notifications in public places by Gun carriers to prove that their Gun is on safety lock.

The same way we're alert about sex offenders living near us, is the same reason we need to know when an illegal firearm is being carried near our family, children, schools, jobs, and homes.

In this ballot initiative, a principle compelling federal courts to defer to a government agency interpretation of an ambiguous or unclear statute that congress delegated to the agency to administer, However; it haven't been done correctly or at the best interest of citizens public servants, Because Research society for the prevention of firearms related harms: (Studying Firearm Harms) Does not promote Gun control and this innovation can be an break thru therapy for citizens safety and for Gun safety until something better is created.

4. weapon and AMMO exchange for sentences rehabilitation reductions .

while Gun drives cost government money, this new ballot initiative does not cost a dime or penny ; citizens care more about their family and love one's than \$100 , sort of disrespect to gun owners, holders, and finders. This will also save taxpayers dollars ; reduce mass incarcereations and reduce poverty .

IF the government agree to collect Gun and AMMO to reduce crimes rates such Robberies, murders, car jacks and assaults while arm in exchange or SWAP out for sentences suspended reductions starting with the end probation or parole Next the front number. family would help their lone one's receive a shorter sentence suspension reduction; some incarcerated over weapons would probably dig them out their stash.

This would take a lot of Firearms off the streets Globally and reduce the crime rates , it's free and the government can credit the prisoner for making the streets safe for citizens and tax payers pockets , Citizens would actually buy a weapon or ammo once to help reduce a family member sentence. while DC council calls for emergency status on opioids to pass a measure and declare a public health emergency. This ballot initiative urges Mayor Muriel E. Bowser (D) to declare or define the drug addiction as an disease of the brain and treat it under a new NIH research for sphyiological dependency.

Not by allocating Funds from another crisis that's already devastating the DC area, we must follow suit and be responsible from the U.S. Department of Health, Human Service Department and NIH National Health Institute must all come together.

This ballot initiative proposed that addicts with opioid, fentanyl, and molly substance use disorder be treated as an disease, and given medication prescription injections of the same substance use disorder in taking if it was the real. To continue going on and looking at users addictions illegally is an understatement. It's clear the district is failing in its leadership when it come to human beings health;

one way to combat the mass overdoses from the powerful synthetic opioid fentanyl is sphyiologicaly physically prescriptions of medications.

while Fentanyl is a medication syndated drug spray for cancer converted into powder, it can be converted to not do harm.

freeing up resources does nothing to stop people from overdosing and using it; how much time do people need to watch more deaths occur.

Another proposal in this ballot initiative is to bring all addicts together at one stationary destination for usage, this will remove a lot of crime and filth from society and reduce shoplifting or theft by treating their disease for what it is.

while D.C. ranks first in all drug overdoses and second in opioid overdose death per capital, behind west virginia according to Centers for Disease Control and Prevention data.

The vast majority is black men in wards 5, 7, and 8 and its time to address it,

while naloxone and fentanyl test strip does not and will not solve the problem, it can be a waste of \$180 million dollars of taxpayers money.

The opioid Abated Advisory commission and The Department of Behavior Services, the District lead opioid response agency allow another \$25 million to be wasted if the medication to treat opioid use is not opioid. you can not put orange juice in a car for gas an expect it to start or work, so our public servants need to stop politician with people life in danger.

The live long D.C. Plan is a failure and this ballot initiative can be the break thru therapy for overdose for any Brain diseased, that NIH has already done test and research on people that uses all sorts of drugs such as opioids, cocaine, molly, and fentanyl.


